CALL TO ORDER

The Public Hearing concerning a 180 day moratorium on convenience was called to order by Mayor, Edwenna Perkins, at 7:00 P.M., in the Council Chambers at 125 South 5th Avenue, Maywood, IL 60153.

PUBLIC HEARING ON MORATORIUM ON CONVENIENCE STORES AND GENERAL MERCHANDISE RETAILERS

Clerk's Note: the Public Hearing was published once in the local newspaper and mailed to businesses located in the Village.

Mr. Barlow addressed the reason for the Public Hearing and the 180-day Moratorium – discussed the problem with the convenient stores selling "loosies" (cigarettes removed from the packets), loitering, violation of other Ordinances, 24 hours of operation, and crowds gathering late into the evening. The Public Hearing is required by due process of the Village Board to take action on the Ordinance.

Chief Willis distributed handouts to the Board members of information from an ongoing operation by a newly created "tag" team. All 24 stores were visited and photos were taken of the storage and selling areas. The issue of selling loose cigarettes is a major focus for the police department and is being addressed aggressively. The clientele patronizing these stores are aware that the police are actively working to rid the village of this practice. The items that are being sold are not illegal, but the illegal items being sold are behind the counters and difficult to prove their existence. The owners will not sell illegal items to a police officer. The same store type in other areas does not sell the merchandise being sold in the Village of Maywood.

Sergeant Diaz reported he was in full uniform, was able to purchase a pocket digital scale, glass pipe, a sleeping aid (used to cut heroine), blunts and blunt cutters. Sergeant Diaz was also given some of the items as a promotion for buying other items.

Mayor Perkins questioned if there was a law against selling the items. Chief Willis informed the Mayor that the items being sold are not illegal.

Trustee Rivers thanked Chief Willis for the hard work the police officers are doing for the Village. Trustee Rivers inquired about a list created by the village attorney and Chief Curry (4 months ago) on synthetic drugs and wanted to know if it was tied into the scope of the investigation. Mike Jurusik informed Trustee Rivers that the process of this Ordinance and review of the code book will include all aspects of the items being sold. The 180-Day Moratorium will include training and education to the police officers for any new regulations once the regulations have been set.

Trustee Rivers asked if the Village was able to cease and desist the sale of all items immediately. Mike Jurusik stated that cease and desist would only apply to illegal items and if the items were a part of the criminal books.

Trustee C. Ealey-Cross questioned if Chief Willis could verbally confirm that he is was aware of "what is on the books" for illegal and non-illegal items being sold. Trustee Ealey-Cross questioned if all stores were visited and checked for these items regardless of their reputation.

Trustee Rivers questioned with the assistance of Code Enforcement, would the police be able to search behind the counters of these stores. Chief Willis advised that <u>any items concealed in drawers at these stores</u>, even with Code Enforcement, would not be accessible without probable cause and a warrant.

Trustee Ealey-Cross requested that Mr. Barlow give a brief description of the Ordinance for convenient stores. Mayor Perkins advised that the Ordinance would be read by Mr. Barlow before the Public comments.

The Ordinance was read by Mr. Barlow.
