4. Pledge of Allegiance to the Flag

Everyone remained standing and recited the Pledge of Allegiance to the Flag of the United States of America.

A. Mayor's Report:

Trustee Jaycox made announcements of interest to the community.

1. Presentation of plaques to outgoing Trustee Audrey Jaycox and Trustee Cheryl Ealey-Cross.

Mayor Perkins presented Trustee Jaycox with a plaque thanking her on behalf of the Village of Maywood and the Board of Trustees for ten (10) years of service noting her commitment and honorable service will be remembered.
