

**ORDINANCE NO. CO-2013-18**

**AN ORDINANCE APPROVING AN AMENDMENT TO  
TITLE XI (BUSINESS REGULATIONS), CHAPTER 111 (GENERAL  
BUSINESS REGULATIONS), SECTION 111.27 (SECONDHAND DEALERS)  
OF THE MAYWOOD VILLAGE CODE RELATIVE TO THE CREATION AND  
ISSUANCE OF A CLASS D SECONDHAND DEALER BUSINESS LICENSE**

**(BERNICE MARTIN d/b/a  
BEST & BEYOND FOR THE 609 LAKE STREET PROPERTY)**

**WHEREAS**, the Village of Maywood is a home rule unit pursuant to the provisions of Article VII, Section 6(a) of the Illinois Constitution of 1970; and

**WHEREAS**, Section 111.27 (Secondhand Dealers), Chapter 111 (General Business Regulations), Title XI (Business Regulations) of the Maywood Village Code currently sets forth various business license regulations and standards pertaining to secondhand dealers allowed to operate in the Village of Maywood, including the maximum number of dealers for each of the various subclasses of licenses; and

**WHEREAS**, Section 111.27(P)(2) of the Maywood Village Code further provides that if a license previously issued is revoked, not renewed or abandoned, the number of licenses authorized to be issued shall be reduced by one (1); and

**WHEREAS**, pursuant to Section 111.27(D)(3) of the Maywood Village Code, the maximum number of business licenses authorized for the business of a Class D secondhand dealer is one (1), but currently there are no Class D secondhand dealers operating in the Village; and

**WHEREAS**, the Village has received an application to open a Class D secondhand dealer retail establishment at the 609 Lake Street property from Bernice Martin of 1750 Riverwoods Drive, Melrose Park, Illinois (the "Applicant"). The Applicant's secondhand dealer retail establishment shall be named "Best & Beyond" and shall sell adult and children apparel and related accessories; and

**WHEREAS**, pursuant to the authority provided by its home rule powers, the President and Board of Trustees of the Village of Maywood have determined that it is in the best interests of the health, welfare and safety of the residents of the Village of Maywood to create one (1) Class D secondhand dealer business license for the purpose of issuing the business license to the Applicant for her to operate the

secondhand dealer retail establishment at the 609 Lake Street property pursuant to Section 111.27 (Secondhand Dealers), Chapter 111 (General Business Regulations), Title XI (Business Regulations) of the Maywood Village Code.

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** The findings set forth above are incorporated by reference into this Section 1 as if fully recited herein.

**SECTION 2:** The President and Board of Trustees of the Village of Maywood authorize the creation of one (1) Class D secondhand dealer retail business license, and further authorize the issuance of a Class D secondhand dealer retail business license to Bernice Martin of 1750 Riverwoods Drive, Melrose Park, Illinois, to operate a store known as "Best & Beyond" at the location of 609 Lake Street, Maywood, Illinois, pursuant to Section 111.27 (Secondhand Dealers), Chapter 111 (General Business Regulations), Title XI (Business Regulations) of the Maywood Village Code

**SECTION 3:** All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

**SECTION 4:** Each section, paragraph, clause and provision of this Ordinance is separable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

**SECTION 5:** Except as to the Code amendments set forth above in this Ordinance, all Chapters and Sections of the Maywood Village Code, as amended, shall remain in full force and effect.

**SECTION 6:** This Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.

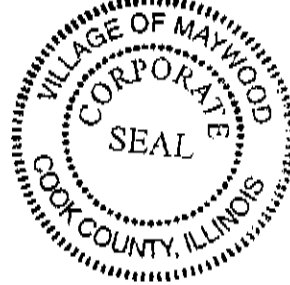
