

ORDINANCE NO. CO-2021-24

**AN ORDINANCE AMENDING
CHAPTER 72 (STOPPING, STANDING AND PARKING) AND
CHAPTER 76 (PARKING SCHEDULES) OF TITLE VII (TRAFFIC CODE),
INCLUDING SCHEDULE IV (LIMITED PARKING), OF THE MAYWOOD VILLAGE CODE**

WHEREAS, the Village of Maywood (the "Village") is a home rule unit pursuant to the provisions of Article VII, Section 6(a) of the Illinois Constitution of 1970, including the right to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, Section 11-1-1 of the Illinois Municipal Code (65 ILCS 5/11-1-1) grants to municipalities the authority to pass and enforce all necessary police ordinances; and

WHEREAS, Section 11-80-2 of the Illinois Municipal Code (65 ILCS 5/11-80-2) grants municipalities the authority to regulate the use of streets within the Village; and

WHEREAS, Section 11-208 of the Illinois Vehicle Code (625 ILCS 5/11-208) authorizes local authorities within the State to restrict the use of highways as authorized in Chapter 15 of the Vehicle Code; and

WHEREAS, the President and Board of Trustees of the Village of Maywood desire to make certain amendments to Chapter 71 (Traffic Regulations) and Chapter 76 (Parking Schedules) of Title 7 (Traffic) of the Maywood Village Code concerning the adoption, posting and enforcement of certain on-street parking regulations and restricted parking signs and the issuance of residential-only permits in and around the 800 Blocks of 4th Avenue, 5th Avenue and 6th Avenue for the 5th Avenue Business Corridor due to the impact of residents with vehicles residing at the Interfaith Mixed-Use Redevelopment Project and the limited amount of on-street parking for local businesses operating within the 5th Avenue Business Corridor (the "Code Amendments") as follows:

- A. 2-Hour Parking / Customer Parking Only Signs on the North Side of Warren Street from the West Line of 4th Avenue to the East Line of the North-South Public Alley that is West of the West Line of 5th Avenue;
- B. 2-Hour Parking / Customer Parking Only Signs with Residential-Only Overnight Parking on the South Side of Warren Street from the West Line of 4th Avenue to the East Line of the North-South Public Alley that is West of the West Line of 5th Avenue;
- C. 2-Hour Parking / Customer Parking Only Signs with Residential-Only Overnight Parking on the North Side of School Street from the West Line of 5th Avenue to the East Line of the North-South Public Alley that is West of the West Line of 5th Avenue; and
- D. No Overnight Parking Signs (11:00 P.M. to 6:00 A.M.) on the East Side and West Side of 6th Avenue between the South Line of Warren Street and the North Line of School Street;

and

WHEREAS, as a home rule unit of local government, the Village may regulate property and property owners located within the corporate boundaries of the Village; and

WHEREAS, pursuant to its home rule authority granted under Article VII, Section 6 of the Illinois Constitution of 1970, and the authority granted under the applicable provisions of the Illinois Municipal Code (65 ILCS 5/) and the Illinois Vehicle Code (625 ILCS 5/15), the Village President and Board of Trustees find that adopting the Code Amendments set forth below is in the best interests of the Village, the Village residents, business owners, property owners and the public.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Each Whereas paragraph set forth above is incorporated by reference into this Section 1.

SECTION 2: Schedule IV (Limited Parking Zones) of Chapter 72 (Stopping, Standing and Parking) of Title VII (Traffic Code) of the Maywood Village Code is amended as follows (new text is marked with underlining; deletions to existing text marked using strikethrough):

“SCHEDULE IV. LIMITED PARKING.

In accordance with § 72.26, the following are designated limited parking zones: ***

(I) Parking Restrictions for the 800 Blocks of 4th Avenue, 5th Avenue and 6th Avenue:

- A. 2-Hour Parking / Customer Parking Only Signs on the North Side of Warren Street from the West Line of 4th Avenue to the East Line of the North-South Public Alley that is West of the West Line of 5th Avenue;
- B. 2-Hour Parking / Customer Parking Only Signs with Residential-Only Overnight Parking on the South Side of Warren Street from the West Line of 4th Avenue to the East Line of the North-South Public Alley that is West of the West Line of 5th Avenue;
- C. 2-Hour Parking / Customer Parking Only Signs with Residential-Only Overnight Parking on the North Side of School Street from the West Line of 5th Avenue to the East Line of the North-South Public Alley that is West of the West Line of 5th Avenue;
and
- D. No Overnight Parking Signs (11:00 P.M. to 6:00 A.M.) on the East Side and West Side of 6th Avenue between the South Line of Warren Street and the North Line of School Street.”

SECTION 3: To the extent necessary, all tables of contents, indexes, headings, and internal references or cross-references to sections that need to be amended or deleted within the Maywood Code of Ordinances, as amended, as a consequence of the above Code Amendments, shall be amended by the Village’s codifier so as to be consistent with the terms of this Ordinance.

SECTION 4: All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

SECTION 5: Each section, paragraph, clause and provision of this Ordinance is severable and, if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

SECTION 6: Except as to the Code amendments set forth above in this Ordinance, all Chapters and Sections of the Maywood Village Code, as amended, shall remain in full force and effect.

SECTION 7: This Ordinance shall be in full force and effect immediately upon its passage, approval and publication as required by law.
